## New Federal District Courts on Bankruptcy Matters.

Dear clients and friends,

On February 2, 2022, the Plenary Session of the Federal Judiciary Council approved the creation of the First and Second District Courts on Bankruptcy Matters, with residence in Mexico City and jurisdiction throughout the Mexican Republic, as well as the establishment of the Central Filing Office of such courts, whose functions are scheduled to begin on March 7, 2022.

The administrative order issued by the Plenary of the Federal Judiciary Council states, among other things, that all District Courts throughout the country must send to the new District Courts on Bankruptcy Matters, all the insolvency proceedings (*concurso mercantiles*) which have been filed as of November 16, 2020 and have not issued a final judgment yet, including all amparo proceeding derived from such bankruptcy proceedings.
